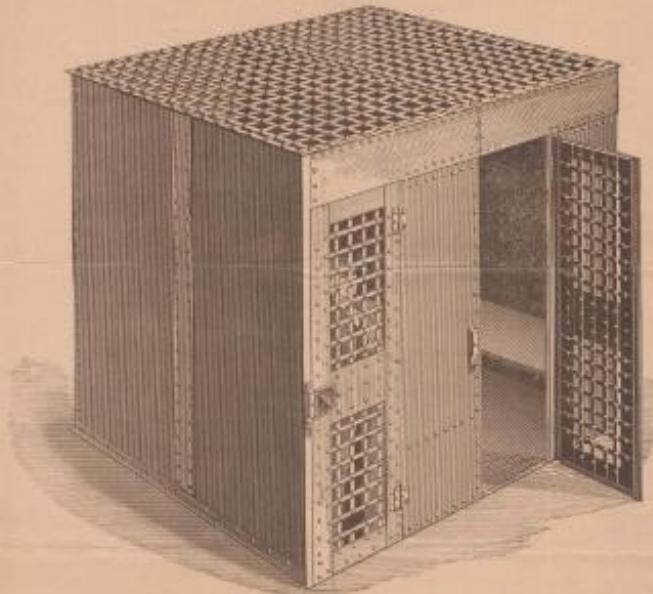


# Basic Detail Report

## TO CITY AND TOWN OFFICERS.



City and Town authorities are often seriously embarrassed to provide for the temporary confinement of prisoners charged with petty crimes, owing to the lack of a proper place in which to confine them. To supply this want we have designed a

### JAIL CELL OR LOCK-UP

Illustrated in the accompanying cut, which being built of Iron or Steel, at reasonable cost, affords a perfect means of disposing temporarily of this class of criminals. We respectfully invite your attention to their merits. The Cells shown in the illustration are built either singly or in rows, consisting of as great a number of Cells as may be required. The cut shows ~~two~~ Cells of our Standard size, which is four feet in width, by seven feet high and seven feet long.

### These Cells are Made of Iron or Steel

As may be required. They are so arranged that the partition between the Cells is tight, in order that there may be no communication between the prisoners. For the purpose of ventilation the roof is made of Iron Lattice with Wire Netting riveted between the lattice bars to prevent the prisoner attaching anything to the top of the Cells. In order to examine the inside without opening the Cells, the doors are made of Iron Grating and an opening is provided at the lower part of each door to pass food to the prisoner without unlocking the door. The Cells are designed for a wooden bunk or seat on one side of the cell and the doors are provided with a No. 4 Yale Fire Cell Lock, with two bolts engaged together.

### THE DOORS ARE SELF-LOCKING.

These cells are made to lock down to stone or cement floor, but in case it is desired to set them upon wooden floors, we make an iron bottom for each cell. The cells can be shipped in sections so that they can be put through the door of any existing building and put together by any ordinary workman.

In writing for prices upon these cells, please state the number of cells required and give us a sketch showing the proposed arrangement of the cells and also state whether the cell is to be put in an existing building or whether it is to be shipped from the works bound up complete to go into a new building and also whether it is to be set upon a wall or cement floor.
