## Welcome to the Coastal Link

The Coastal Link is a collaborative effort of the Greater Bridgeport Transit Authority, Milford Transit District and the Norwalk Transit District.

Funding is provided through Federal Jobs and the Connecticut Department of Transportation (DOT/MDOT).

### How to use the Coastal Link

Please be sure that you are on the Coastal Link. Coastal Link vehicles will have a Coastal Link sign attached to the front of the bus. The front destination sign will also indicate a Coastal Link vehicle. Coastal Link buses may supplement parts of existing routes in your transit provider's service area.

The Coastal Link is an inter-district service. This is a seamless service and requires NO transfers. If you are expecting to use another route please request a transfer upon boarding.

#### ELDERLY AND HANDICAPPED SERVICES

Senior citizens and persons with physical handicaps are entitled to a reduced fare of \$.50 with approved identification. Approved identification for purposes of reduced fares are the Medicare Card and the State of Connecticut Elderly or Handicapped Identification Card. To qualify for the Elderly reduced fare, a person must be 65 years of age or older. Certification by a medical doctor must be obtained to qualify for the Handicapped reduced fare. Application for a State Elderly and Handicapped Identification Card can be obtained from your transit provider.
