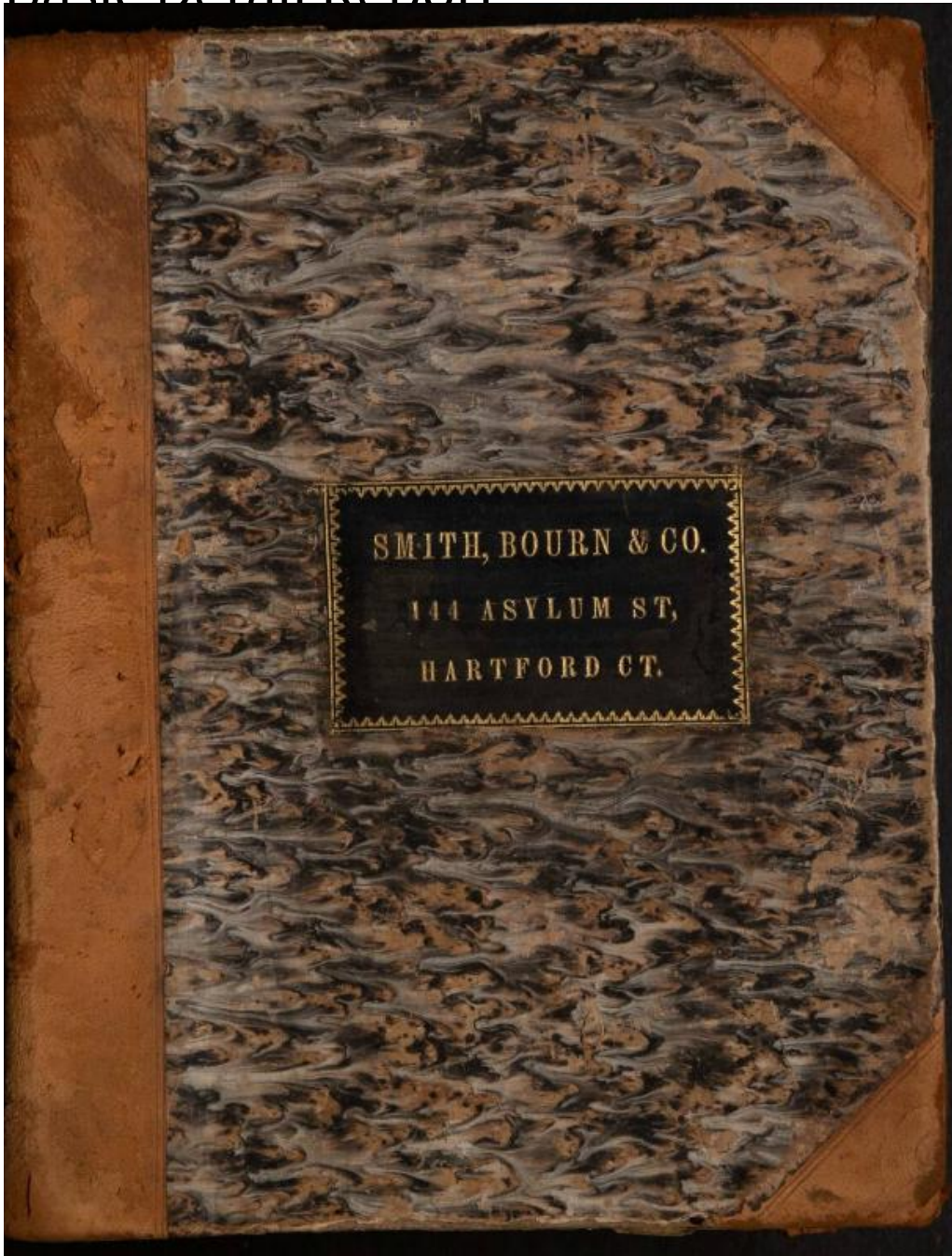

Description Photograph album for the display of cartes-de-visite (CDV)

photographs. The album contains 71 CDVs all depicting side views of various models of Smith, Bourne & Co. saddles. The saddle types are noted above each image in pencil.
